DALLAS, Oct. 05, 2020 (GLOBE NEWSWIRE) -- **Primoris Services Corporation (NASDAQ Global Select: PRIM)** (“Primoris” or “Company”) today announced the renewal of a Master Service Agreement (“MSA”) with a major energy customer with an anticipated value of over \$110 million. The contract was secured by the Power, Industrial, & Engineering segment. This award was signed in the third quarter of 2020.

- The award is for a five-year pipeline maintenance MSA in the Canadian oil sands.
- It is estimated that the MSA will generate approximately \$22 million per year over the course of the contract. While the agreement does not obligate the customer to award Primoris a specific dollar amount, our discussions and history with the customer form the basis for our anticipated value.
