- ▮ The project involves widening the existing LA 1 bridge at the North Connector and extending the existing LA 1 mainline bridge. The project will be constructed utilizing barge mounted cranes and marine equipment.
- ▮ Work is scheduled to commence in the second quarter of 2018 and to be completed in the first quarter of 2020.
