- Shares of Common Stock held by SaraJen Capital LLC, a California Limited Liability Company, of which Mr. Tucker is a one-third member and sole manager with full dispositive power over these shares.
- The non-employee director compensation program adopted by the Board in May 2011 and updated August 5, 2014, provides for the issuance of restricted stock with a value of \$46,667. The price per share was based on the average closing price during June 2019, resulting in a grant of 2,411 shares of stock. The shares of stock cannot be sold for a period of twelve months from the date of grant.
